



### **Felisa S. A. (Sally) Lewis '90**

Sally was commissioned as a Military Intelligence officer, with assignments as a platoon leader at Fort Ord, CA, 1991-93; battalion S-1 and headquarters company commander in Panama, 1994-96; and Assistant Professor, Department of Social Sciences, USMA, teaching economics and international relations from 1998 to 2001. During her tour at West Point, she was inspired to serve others in a different capacity as a physician. Returning to the rank of second lieutenant, she attended medical school at the Uniformed Services University of the Health Sciences (USUHS) in Bethesda, MD, graduating in 2005, and completed her Dermatology Residency at Walter Reed in 2009. As a board-certified dermatologist, Sally served as a staff dermatologist at Madigan Army Medical Center, Fort Lewis, WA; medical director, Rader Army Health Clinic, Fort Myer, VA; and as Chief, Dermatology Clinic, Fort Belvoir Army Community Hospital, VA, culminating her 26-year Army career in 2016. Her other degrees include a Master of Arts in International Relations (Johns Hopkins SAIS) and a Master's in Public Health from Johns Hopkins, MD.

After she retired from the Army in 2016 until 2020, Sally practiced dermatology in a locum tenens capacity, with short-term contracts in Washington state, Oregon, California, Ohio, and Maryland. In addition, Sally holds an active medical license in Virginia. The flexibility of these assignments allowed her to devote more significant time to her family and volunteer pursuits. In April 2020, Sally took a job at the Food and Drug Administration as a clinical reviewer in the Division of Dermatology and Dentistry.

Sally began her WPAOG service on the Advisory Council in 2012 as a western Regional Advisor while stationed in Washington. She continued as an Advisor-at-Large from 2015 to 2017 after moving to the Washington, DC area. She was subsequently elected to the WPAOG Board of Directors, where she has served since 2018. Sally has served on several committees, including the Alumni Support Committee, Governance and Board Affairs, Information Technology, Development, Thayer Award Nominating Committee, and the Distinguished Graduate Award Committee.

In the Washington, DC area, Sally served from 2015 to 2018 as the Executive Director of the West Point Society of the District of Columbia and the National Capital Region (WPSDC), the largest West Point Society. She has also served as its Communications Chair in 2014-15. As Executive Director, she was responsible for the overall coordination and oversight of all WPSDC activities. In 2018, she switched her focus to Admissions and became a Field Force member in Maryland, assisting cadet candidates applying to West Point.

With the world in constant change, Sally's priority as a Director is to ensure that WPAOG continues to evolve and enhance its support to the Long Gray Line, to bring graduates together, and to be reflective of their needs. As a Director, Sally will continue to present innovative ideas to the Board to keep pace with the changing expectations of its graduates. Sally resides in Potomac, MD.
